SUBJECT: AMENDMENT 1

TO ALL STATE AGENCIES AND OTHERS AUTHORIZED TO USE STATE CONTRACTS:

Amendment 1 has been issued to correct the pricing on the Securitas Security Services, Inc. price list. Amendment 1 also clarifies the rate paid for holidays and the holidays that guards are to be paid for. The overtime pay rate is 1-1/2 times the guard pay rate (supplemental rates are paid for the first 40 hours only). The paid holidays are; New Years day, Memorial day, Columbus day, Christmas day, M.L.King Jr. birthday, Independence day, Veterans day, Washingtons birthday, Labor day and Thanksgiving day.
