SUBJECT: REPEAL OF PROCUREMENT CONTRACT FEE

Effective June 22, 2010, Chapter 56 of the Laws of 2010 repealed §163-c of the State Finance Law that required a Procurement Contract Fee on certain centralized contracts.

The Contractors listed above have reduced their **contract prices by the fee amount of one-half of one percent (0.005)**. The Procurement Services Group will continue to work with the remaining contractors for similar reductions.

In addition, the first paragraph of the Report of Contract Purchases clause is changed to read:

REPORT OF CONTRACT PURCHASES:

Contractor shall furnish reports containing total sales for both State agency and authorized non-state agency contract purchases for the duration of the contract. Reports are due annually on January 15 and July 15. For example:
Report Period: January 1 – June 30; reports are due no later than July 15.
Report Period: July 1 – December 30; reports are due no later than January 15.
