What is a restricted period?

- This is the time between when a solicitation is released and the contract is <u>awarded</u>
- During this time, make sure to direct your questions to the designated contacts



What comes to your mind when you think of an IT project?

• Can you identify the core elements of any IT project?

Core Elements of an IT Project – the Project Plan

Identify the parameters, action steps, timing, budget, roles, and resources required to satisfy goals of the project

Core Elements of an IT Project – People

Determine staffing needs (quantity, titles, skill levels, duration) to successfully implement the project

PEOPLE

Core Elements of an IT Project – Products

PRODUCTS

Identify the hardware, software, cloud offerings, and product implementation services needed for the project

PBITS

PROJECT PLAN

Hire a deliverable-based IT Consultant to analyze needs and identify resources required to satisfy goals of the project

PRODUCTS

Solicit Manufacturers and/or Distributors to procure IT product needs (hardware, software, cloud, product implementation services)

PEOPLE

Hire hourly-based IT staff to augment staffing needs to successfully implement the project

How Do I Know How to Put the Pieces Together?


Develop your scope, then get R.E.A.L.

- $\underline{\mathbf{R}} \mathbf{REVIEW}$ your scope
- **<u>E</u>** Qualitatively **EVALUATE** yourself using the same criteria
- <u>A</u> Objectively **ASSESS** your in-house capabilities in each area

<u>L</u> – LEVERAGE in-house strengths/LEAN on OGS contracts for the rest

Hourly Based Information Technology Services (HBITS)


- This contract is used to secure quality IT consulting services on an hourly basis for staff augmentation for up to 30-month engagements
- Payments are based on fixed hourly pricing according to job titles, skill levels, and region






HBITS Contract Structure

 Qualified candidates are selected based on job title, skill level, and region





Project Based Information Technology Services (PBITS)

- This contract is used to obtain <u>IT consulting services</u> for individual IT projects
- Payments are made for accepted fixed priced deliverables, not on an hourly basis


Examples of Eligible Projects:

- Project management support services
- Data categorization
- Data information management (migration, conversion, manipulation, integration)
- Implementation of open-source software



PBITS Contract Structure

• The contract is divided into lots based on anticipated project cost





PBITS: 1. Develop scope of 2. Receive internal work and other approvals **Process** project documents **Overview** 5. Release the 4. Develop mini-bid document using mini-bid to **PBITS** mini-bid contractors & template collect responses 8. Finalize mini-bid 7. Notify all contractors who with the contractor responded

3. Collect mini-bid participation interest forms (optional)

6. Evaluate responses & make determination

9. Change your project budget & duration (if needed)

PBITS Benefits to You

- Contractor responsible for producing a viable product
- Diversity of contractors
- Up to 36-month engagements at transaction level
- Ability to require additional insurance at transaction level
- Enhancement budget is available

Umbrella Manufacturer and Distributor Contracts

- These contracts are used to obtain IT <u>products</u> from the manufacturer or one of their designated resellers for the contract, or from the distributor in cases where the items are not available from the manufacturer
 - Manufacturer Umbrella hardware, software, cloud and implementation services



• Distributor Umbrella- only hardware and software




Umbrella Manufacturer Structure

• The contract is divided into lots based on product type




Umbrella Distributor Structure


