#### Call to Order

#### **Welcome and Introductions**

Sean Carroll, New York State Office of General Services ("OGS") Chief Procurement Officer ("CPO") and acting Chair of the New York State Procurement Council ("Procurement Council") as the designee of the Commissioner of General Services, called the meeting to order.

#### **Old Business**

<u>Meeting Minutes:</u> Mr. Carroll called for a motion to adopt the minutes of the September 5, 2019 meeting. The motion to adopt the minutes passed by a vote of 15-0.

<u>Rules Workgroup Update</u>: Mr. Carroll reported that the Rules Workgroup requested OGS staff draft an initial proposed set of rules to be reviewed by the Rules Workgroup. OGS is currently finalizing a draft to be presented to the Rules Workgroup. Mr. Carroll stated that OGS will be scheduling another Rules Workgroup meeting shortly.

<u>Procurement Guidelines Workgroup Update:</u> Mr. Carroll reported that the Procurement Guidelines Workgroup continues to review the draft Procurement Guidelines for, among other things, distinguishing items that are policy from those that are educational or training, and adding SDVOB language where appropriate. The Procurement Guidelines Workgroup has postponed presenting the draft Procurement Guidelines to the Procurement Council until such review is completed.

#### **New Business**

<u>Presentation – Farm to School:</u> Sarah Barton, Department of Agriculture and Markets, gave a presentation on the thirty percent (30%) State reimbursement initiative in the 2018 NYS Budget to help New York State schools increase their purchase of New York State Food Products.

<u>Presentation – PBITS:</u> Charles Strickland, OGS, gave a presentation on the Project Based Information Technology Consulting Services contract.

<u>Legislative Update:</u> Mr. Carroll reported on the recent changes made by the Attorney General's Office to Appendix A as follows:

- 1. clause 5 has been updated to track changes in the Human Rights Law that became effective October 11th, 2019;
- 2. clause 22 has been updated to require compliance with General Business Law 899-BB, which goes into effect in 2020; and
- 3. a new Clause 27 has been added to account for situations where OSC or the Attorney General's Office will allow agencies to submit electronic versions of contracts rather than versions with wet signatures.

Mr. Carroll then addressed a previous question about whether Procurement Council meetings could be held remotely or digitally. Mr. Carroll explained that there are regulatory and technological challenges to holding the Procurement Council meetings remotely or digitally. Therefore, Procurement Council meetings will continue to be held in person. However, OGS will continue to review these issues.
