Call to Order

Welcome and Introductions

Sean Carroll, New York State Office of General Services ("OGS") Chief Procurement Officer ("CPO") and acting Chair of the New York State Procurement Council ("Procurement Council") as the designee of the Acting Commissioner of General Services, called the meeting to order.

Old Business

<u>Meeting Minutes</u>: Mr. Carroll called for a motion to adopt the minutes of the November 6, 2021 meeting. The motion passed unanimously.

Legislative Update

Tyler Feane, OGS, reported that Chapter 1 of the Laws of 2022 was signed on January 14, 2022, extending the authorization for public bodies to hold meetings remotely under the Open Meetings Law.

Mr. Feane reported Assembly Bill No. 2591A Senate Bill 542A amending State Finance Law in relation to the procurement of low embodied carbon concrete. This is intended to help New York State meet its carbon emissions goals by requirement and incentivizing the use of concrete that emits lower levels of carbon during the production process. This would require OGS to establish a stakeholder advisory group to develop guidelines and minimum standards for State contracts involving the use of concrete. The bill was signed on December 22, 2021 as Chapter 724 of the Laws of 2021. Its effective date is June 20, 2022 and it will apply to any State contracts advertised on or after that date.

Approval of Preferred Source Designation Applications Under OGS Standing Authority

Sean Hume, OGS, reported that as of January 25, 2021, OGS has approved one item under its standing authority since the last report given on November 4, 2021: NYSID's Eco-Baggeez resealable sandwich bags.

Mr. Hume reported that the Procurement Council received NYSID's report of mail fulfillment on January 5, 2022. A copy of that report has been distributed to the Council members and has been posted to the Procurement Council website.

Preferred source Applications Denials Report

Mr. Carroll reported that the SFL 162 (8)(b) Preferred Source Application Denials report was submitted to the Governor on December 28, 2021. This report stated that during the 2021 calendar year the Council did not deny any Preferred Source applications.

New Business

<u>Changes to Vendor Responsibility Questionnaires and Definition List</u>: Tyler Feane presented proposed revisions to the Vendor Responsibility Questionnaires and Definition list.

Some changes were intended to clarify questions that were either being interpreted by vendors differently from what was intended, or that required additional language to clarify the information sought. Some other minor changes were made to improve the internal consistency within questionnaires and to improve consistency across the questionnaires. The certification language was revised, and the notarization requirement removed by having vendors make the certification under penalty of perjury making submittal of the hard copy questionnaire more business friendly and consistent with the electronic version of the questionnaire, which is accepted without a notarization requirement. Minor edits were made to the definitions list for clarity.

Mr. Carroll called for a motion to adopt the changes to the Vendor Responsibility Questionnaires and Definition list. The motion was passed by a vote of 14-0. The Chair abstained.
