REVISION to Attachment 10 – General Specifications (Revised November 26, 2019)

Attachment 10 – General Specifications (Revised November 26, 2019) has been revised. Section 5.2, Pricing Information has been revised to include the highlighted language:

Price quoted shall be to three (3) decimal places.

Price quoted with the exception of "Fog Seal Prior to Microsufacing" & "Price Additionals" shall be net per ton furnished, hauled, delivered, and applied with Contractor's equipment at the locations indicated by the resident engineer, or Authorized User representative and must include material costs. Microsurfacing shall be applied in accordance with NYSDOT's Standard Specifications and as per the attached specification for microsurfacing. Quick set slurry seal shall be applied in accordance with NYSDOT's Standard Specifications and as per the attached material specification for quick set slurry seal. Cleaning and preparing the existing pavement will be the responsibility of the Authorized User. Erecting warning signs and directing traffic will be the responsibility of the Authorized User or the Contractor using the optional Work Zone Traffic Control section at the discretion of the Authorized User.

<u>Fog Seal Prior to Microsurfacing</u>: Price shall be per gallon furnished, hauled, delivered, and applied with Contractor's equipment at the locations indicated by the resident engineer, or Authorized User representative.
