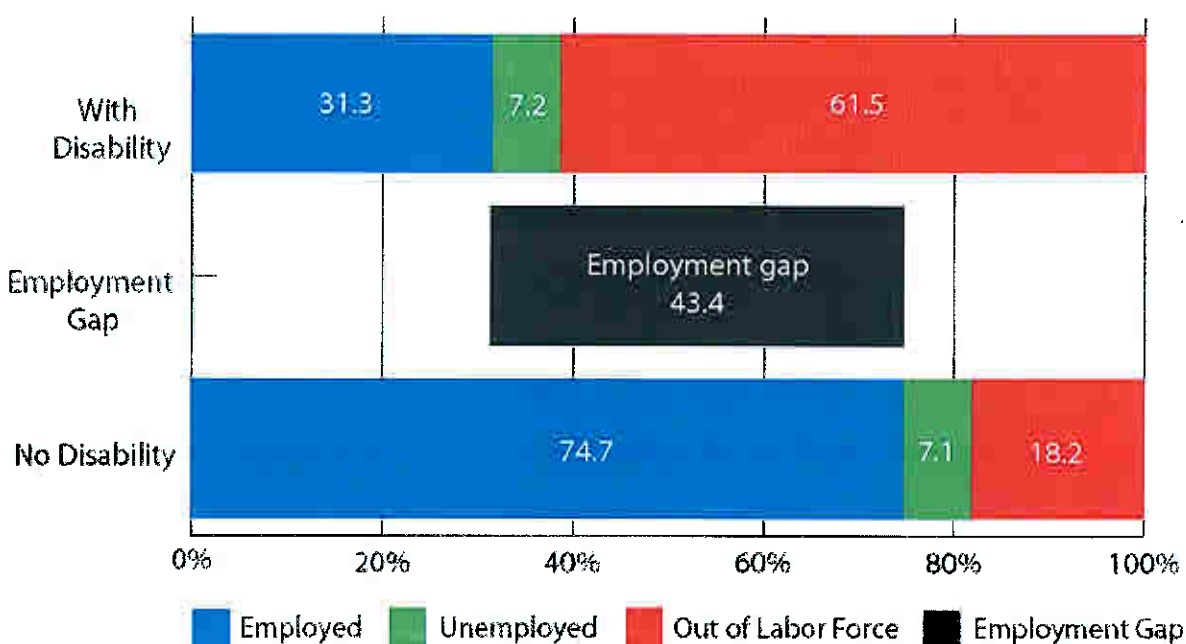
New York State Industries for the Disabled, Inc. (NYSID) is applying to expand the services offered under the category of Document Processing on the List of Preferred Source Offerings [Section D] (see attached modified document "List of Preferred Source Offerings" page 23). While "Photocopying" and "Reproduction" are currently included in the aforementioned category, we are requesting the specific addition of "Digital Printing" on a statewide basis as a third method of Document Processing, in response to technological developments, customer demand and new capabilities at NYSID.

NYSID's intent is to provide Digital Printing services by partnering with NYS businesses, some of which are MWBEs and/or small businesses, in addition to offering Digital Printing through traditional member agencies.

Employment

The addition of Digital Printing to NYSID's list of Preferred Source offerings would significantly increase desperately needed employment opportunities among New Yorkers with disabilities. The New York Makes Work Pay Initiative (NY-MWP) is made up of the NYS Office of Mental Health, Cornell University and Syracuse University. Their 2010 research shows that, "the employment rate for people with disabilities [between the ages of 21-64] in New York State is 31.3 percent, compared with 61.5 percent for people without disabilities, a gap of 43.4 percentage points." NY-MWP also reveals that New York is in a group of states that fare poorly in terms of relative employment of people with disabilities. Over the past 10 years, the Procurement Council has approved four new Preferred Source services for NYSID: Digital Imaging, Industrial Laundry, Secure Document Destruction and Electronics Recycling. In 12, those four services alone added over 240 FTE (Full-Time Equivalent) jobs. In that same time, those services employed workers to perform over 470,000 hours of labor. (See attached charts titled “New Statewide Approved Services Since 2000”.) The addition of each new service provides the potential for thousands of labor hours for New Yorkers with disabilities.

Approved NYSID services also increase business for NYS private industry vendors; NYSID works with ACCESS-VR-approved Corporate Partners (Associate Members) on many of our services. NYSID member agencies have worked with 15 different Corporate Partners on the last four services added to the list of Preferred Source offerings.

Definition:

Digital Printing is defined as a physical process that transfers an image stored in digital format on a computer to a printable material. It does not use metal printing plates as the mechanical means to affix the image to the paper and does not include a press set-up process. The term expressly does not include the mechanical processes of offset lithography and offset printing (traditional printing). Digital Printing uses computerized printing processes enabled by new digital technologies, resulting in faster, lower-cost printing. It is generally used for short-run print jobs, since it does not require a press set-up process. (See attached four-page illustration, “Digital vs. Offset Printing” from Computer Encyclopedia.)

Characteristics of Digital Printing include:

- short-run printing, flexible, on-demand printing processes
- increased speed, lower cost and ease of customization
- elimination of many of the mechanical steps required for conventional printing

Digital Printing services sometimes include Variable Data Printing, a form of customizable (on-demand) Digital Printing. Using information from a database or external file, the printer can change text and graphics from one printed piece to the next without stopping or slowing down the press. For example, a VDP process can print personalized letters with a different name and address on each letter.

Variable Data Printing characteristics include:

- printing with a different name and address on each letter
- “mass-customization” of documents
- computer databases, digital print devices and highly effective software

This application exclusively covers Digital Printing, and does not include offset printing, custom-printed carbonless forms, typesetting, engraved stationary or engraved business cards, silk screen reproduction or map printing. NYSID’s intention is to be the Preferred Source provider for Digital Printing services in all of its forms, including Variable Data Printing, which would expand and complement not only our Document Processing services, but also our Mail Fulfillment services.

In the past NYSID had been precluded from seeking addition to the List of Preferred Source Offerings for this service because of the State Printing and Document Law. An amendment to that law in 2012 allows printing to be treated as a commodity or service, which is why we seek addition of this offering at this time.

Members:

NYSID has five member agencies who partner with NYS small businesses in Corporate Partnerships, as well as three member agencies who offer Digital Printing independently:

- Northeast Career Planning/The Norton Center partners with Camelot Consulting, Inc., DBA Preferred Reproductions, in Albany. Camelot Consulting is a woman-owned business, and a certified NYS MWBE. They have over 10 years in the Digital Printing market, and have been working with Northeast Career Planning/The Norton Center for the past two years. Camelot employs 25 people exclusively for Digital Printing, including five full-time employees from Northeast Career Planning.
- Montgomery County ARC, AKA Liberty Enterprises, partners with Amsterdam Printing in Montgomery County. Amsterdam Printing is one of the oldest and largest printing companies in New York State. They have worked with Liberty Enterprises for more than a decade, at times employing Liberty’s workers in their facility. Amsterdam has offered Digital Printing for the past two years, and employs 50 people for that service.
- Fulton ARC, AKA Lexington Industries, has been working with Miller Printing in Amsterdam since 2008. Miller specializes in complex Variable Data/Mail Merging applications that have to meet rigid HIPPA and/or client issues of security and confidentiality. They employ 14 workers for Digital Printing, having offered that service since 2002.

- ARC of Onondaga County will establish a Corporate Partnership with Avalon Document Services. Together, they provide Digital Printing in Syracuse, Rochester and Buffalo. Avalon has offered Digital Printing services for the past 12 years, and employs 14 people for that service.
- F.E.G.S. intends to partner with New York Digital Color Lithographers & Printers, Inc. (NYDC) in New York City. NYDC has offered Digital Printing for the past 15 years, employing 25 people for that service.
- Fedcap Rehabilitation Services is a NYSID member in New York City that has offered Digital Printing services since 2002. Much of their printing is associated with their mailing services, and three employees work on Digital Printing full-time.
- Oswego Industries, Inc. in Fulton has offered Digital Printing since 2007. They employ three part-time people for Digital Printing.
- Jefferson County ARC, AKA Jefferson Rehabilitation Center, in Watertown has offered Digital Printing since 2002. They currently employ one full-time person for Digital Printing.

This list reflects the NYSID members who currently provide Digital Printing services, although we may add more in the future as the market demands. The current list covers each geographic market in New York State (see attached map, "NYSID Members providing Digital Printing Services").

Capabilities:

Digital printers resemble large copiers, and the operation of Digital Printing equipment requires less skill compared to the expertise needed to operate an offset press. Therefore, with minimal training, Digital Printing can offer employment opportunities to individuals with disabilities that are more difficult with offset printing. The jobs to be performed by New Yorkers with disabilities include:

- Document preparation - Electronically manipulating files to prepare for digital production
- Digital small format - digital reproduction which includes loading and unloading paper from machines
- Digital large format - digital reproduction of architectural and oversized prints
- Finishing - includes several binding processes including stapling, folding, tape binding & perfect binding books, drilling, cutting and inserting
- Quality control and shipping - product quality control, packaging and preparing for delivery or shipment

Digital printers start at an average salary of \$10.50/hour. NYSID hopes to add 10-11 new jobs across New York State, based on one full-time disabled worker for approximately \$100,000 of business, and based on the market estimate detailed below.

Market:

Granting Preferred Source status to NYSID for Digital Printing should increase jobs for New Yorkers, since government agencies may otherwise choose out-of-state vendors to meet their printing/reproduction needs. For example, the State Education Department's contract with Vitalsource Technologies, Inc. (Raleigh, NC) is a Digital Printing contract worth almost \$4 million. Additionally, of the 68 printing contracts listed in Open Book New York, 30 were with vendors outside NYS. (See attached document headed, "Open Book New York.")

State agencies that do in-house printing would most likely save money by using NYSID for Digital Printing services. The Office of the State Comptroller (OSC) performed a Staff Study on Statewide Printing and Reproduction Services (95-D-21), and concluded that in-house printing was not cost-effective:

Many State agencies have their own printing presses and high-speed photocopiers. We examined the cost-effectiveness of these operations and found that improvements were needed. For example, we identified several items that were printed on in-house presses when they could have been printed by commercial vendors under State contract at a fraction of the cost. We analyzed the use of 56 printing presses at 11 State agencies and found that the presses were used for an average of only 37 percent of their capacity. We suggested a number of alternatives for increasing the cost- effectiveness of State agency printing and reproduction operations.

In researching market data for this proposal, NYSID reached out to the following resources:

- OSC
- Open Book New York
- Camelot Consulting
- Amsterdam Printing
- Miller Printing
- Printing Industries of America (PIA)

Digital Printing is a growing section within the printing industry, which is declining in total. Camelot Consulting estimates that between 70-80% of their printing business is digital. According to PIA,

conventional offset printing is projected to decrease 2-3% per year, due to the shift to Digital Printing (see attached article "Digital Printing and Ancillary Services").

Open Book New York records that between 1/1/11 and 12/31/12, NYS agencies spent \$7,676,865.37 on general printing services, or approximately \$4,000,000 per year. It is not specified which of those jobs were for Digital Printing, but it is safe to exclude contracts greater than \$250,000 in two years, since they would be too large for Digital Printing. That leaves 39 contracts, equaling \$3,860,383.24 or about \$2 million per year. We recognize that the contracts on Open Book New York are not comprehensive, but reflect perhaps one-fourth of the State spending for printing services. Therefore, we estimate the total market for Digital Printing among NYS agencies to be about \$8 million.

Historically, NYSID strives to attain 15% of a market; therefore, NYSID hopes to earn about \$1,200,000 per year for Digital Printing. Our Corporate Partners estimate that for every \$100,000 in new sales, they add 40 hours per week to their payroll. Therefore, the approval of Digital Printing would add about 12 new jobs for people with disabilities across New York State.

The approval of this request should result in the increase of Digital Printing business for NYS companies, make Digital Printing easier for NYS agencies that would no longer be required to bid contacts, and save money for agencies who currently print in-house. It will also complement and enhance NYSID's Document Processing and Mail services.

Pricing:

NYSID's pricing for Digital Printing is competitive with other vendors in this industry. NYSID's pricing for Digital Printing is according to the variables of the customer's request. Factors that affect pricing include:

- Paper stock (coated, glossy, etc.)
- Quantity of items printed
- Paper size
- Finishing/binding
- Black and white content vs. full color

Attached is a list of sample prices, averaged from participating NYSID members (see "Sample NYSID Pricing for Digital Printing"). **It is our intent to apply to OGS for individual price approvals as required once Digital Printing is included on the List of Preferred Source Offerings.**

Summary:

NYSID is requesting Procurement Council approval of this service addition to the "List of Preferred Source Offerings" for the following reasons:

Another subpopulation of interest is veterans, particularly those with a service-connected disability. A veteran service-connected disability is measured differently from the definition of disability used elsewhere in this report, and is defined as a disease or injury determined to have occurred in or to have been aggravated by military service (see Glossary for more details). In New York State, there are 476,900 civilian working age veterans, of whom 69,400 (14.6%) have a service-connected disability.

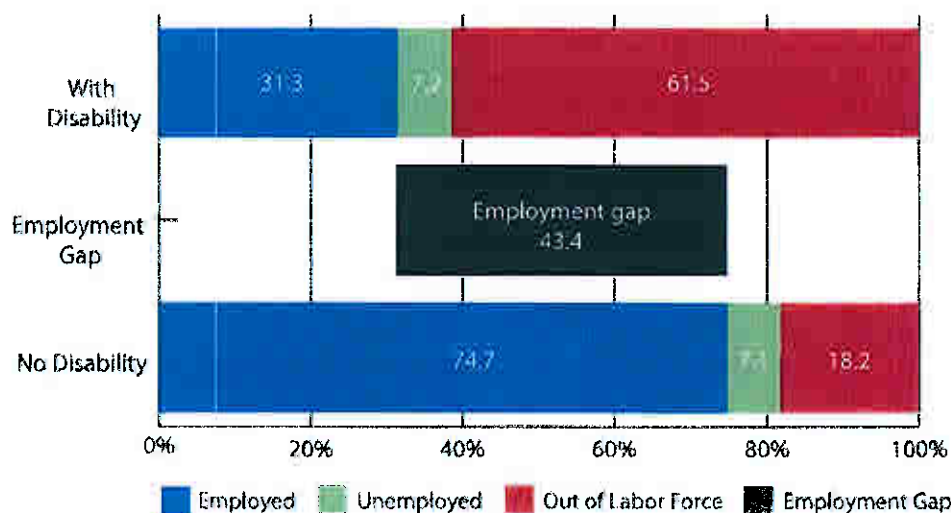
Employment Situation

With a better understanding of the prevalence of disability and the demographic characteristics of people with disabilities, we now explore how the employment situation of people with disabilities differs from that of their peers without disabilities.

Employment Rates

The employment rate for people with disabilities in New York State is 31.3 percent, compared with 74.7 percent for people without disabilities, a difference of 43.4 percentage points (see Glossary for more information on employment). Exhibit 3 presents the employment rates (in blue) and highlights the employment gap (in black), which is the difference in the employment rates between people without and with disabilities. The corresponding national employment rates are 33.8 percent and 75.3 percent, respectively, resulting in a gap of 41.5 percentage points.

Exhibit 3. The Employment Situation of New Yorkers, by Disability Status

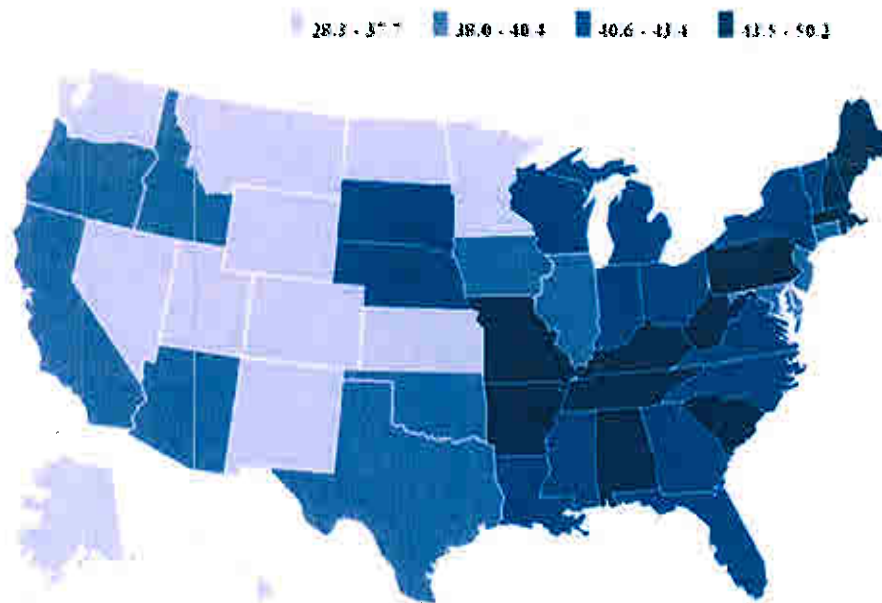

A person is defined as “not working but actively looking for work” if he or she reports not being employed but has been actively looking for work during the last four weeks. Someone who is not working and not actively looking for work is considered “out of the labor force.” Exhibit 3 illustrates that people with disabilities are far more likely than people without disabilities to be out of the labor force -- 61.5% vs. 18.2%, respectively. An estimated 69,900 people with disabilities are unemployed, that is, not working but actively looking for work. Among people who are not working, people with a disability were less likely to have worked at some point in the previous 12 months (10.0%) than people without a disability (25.4%).

Working-age New Yorkers with disabilities are employed at less than half the rate of their non-disabled peers. Exhibit 4 provides the nationwide distribution of state-wide employment gaps -- the darker the shade of blue, the greater the employment gap. The figure shows that New York is in a group of states with a larger employment gap.

Exhibit 4. Employment Gaps by State



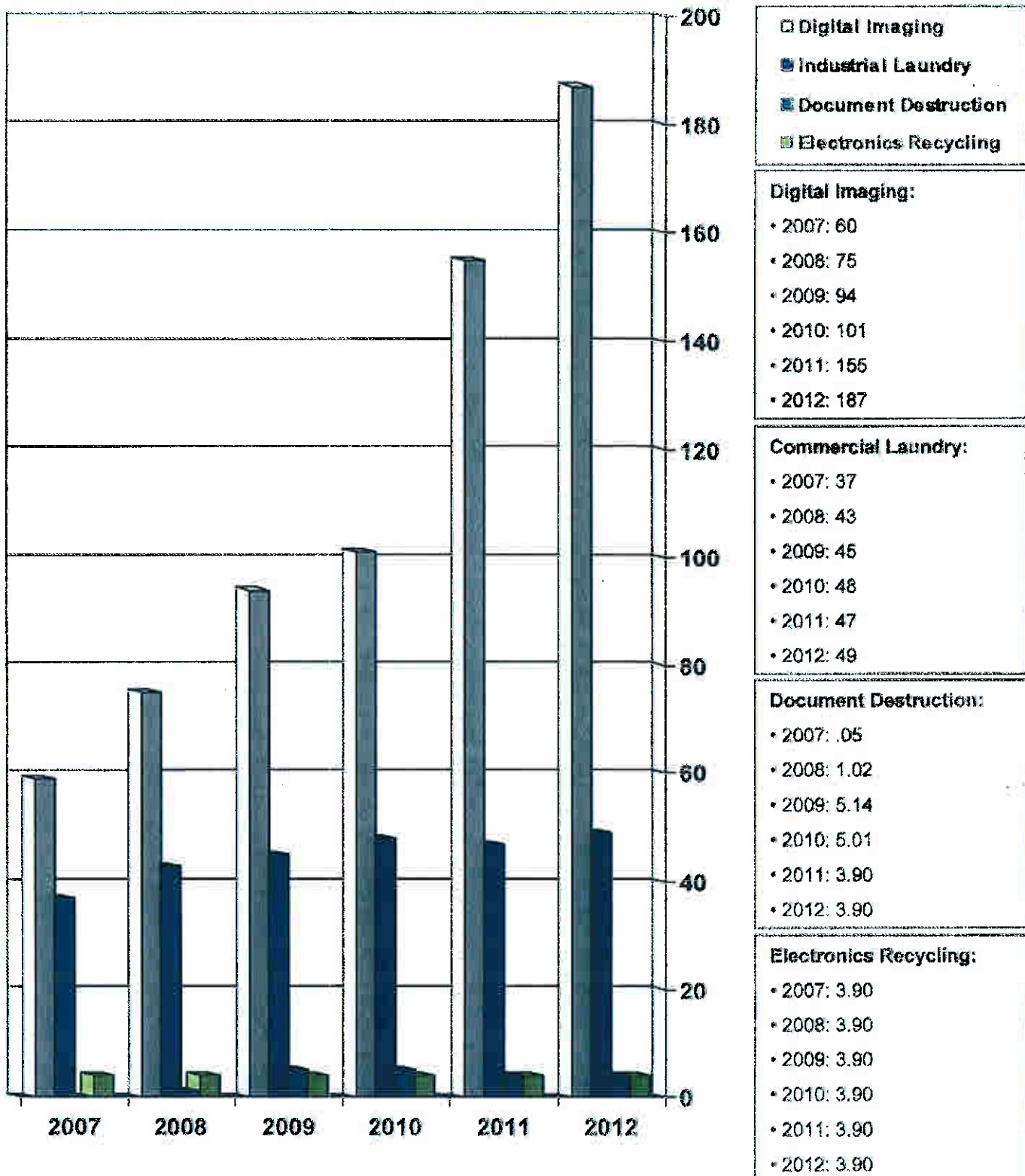

In general, regardless of disability status, employment rates tend to be lower for women than for men. This difference holds in New York State: the employment rate for women with disabilities is 30.0 percent compared with 32.7 percent for men with disabilities. Employment rates are lower for racial/ethnic minorities with disabilities, with 28.5 percent employed compared with 32.8 percent of White, non-Hispanics. Employment rates among people with disabilities also vary across race/



New Statewide Approved Services Since 2000

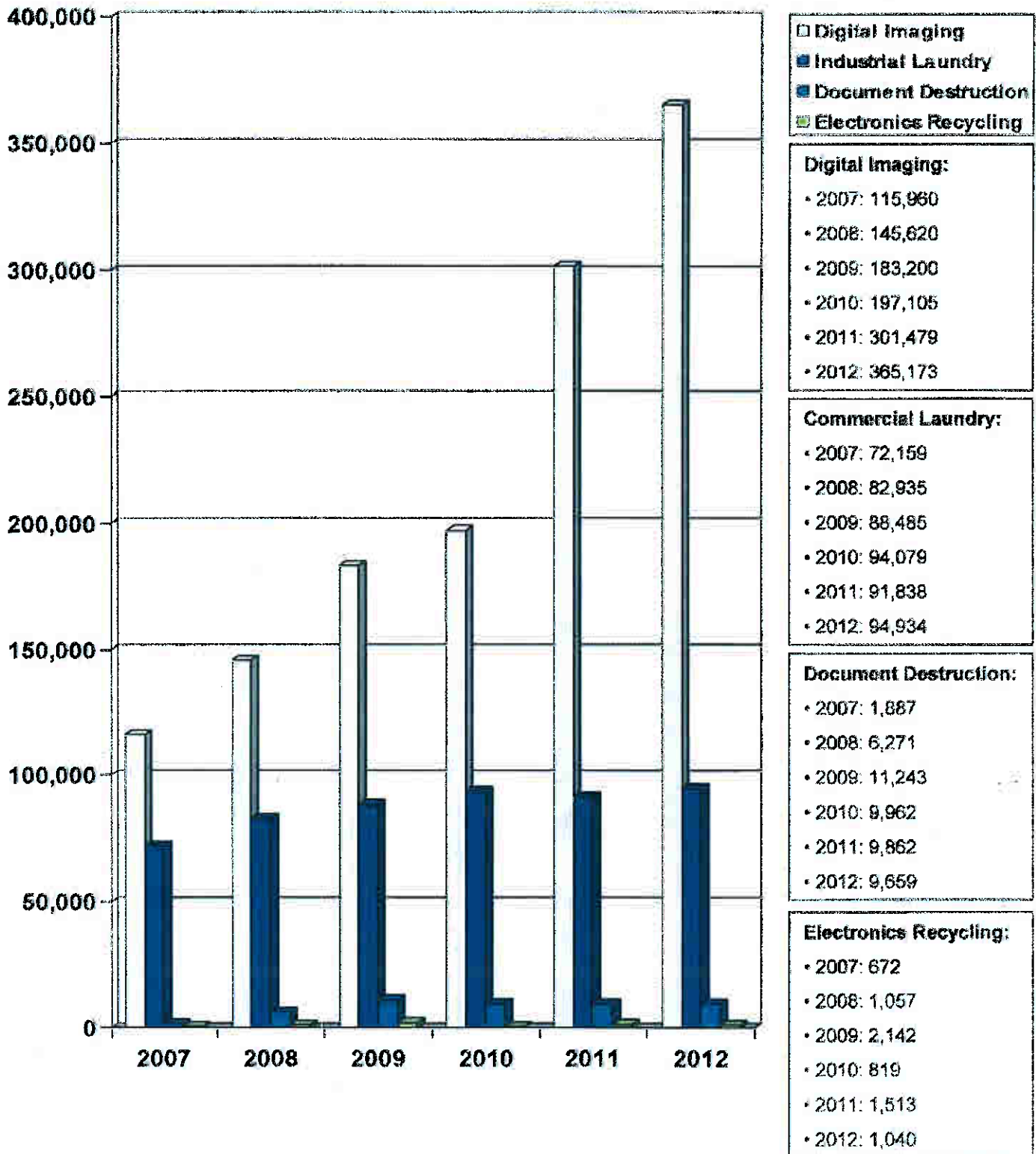
Employed FTE's Since 2007

Digital vs. Offset Printing

Definition of: digital printing

All printed output from a computer is technically digital. However, the term refers more to printing finished pages for brochures, journals and booklets from the computer rather than using an offset printing press and commercial printer. Although digital printer systems do not compete with high-speed newspaper and magazine presses, it is expected that these "analog" monsters will become all digital in time.

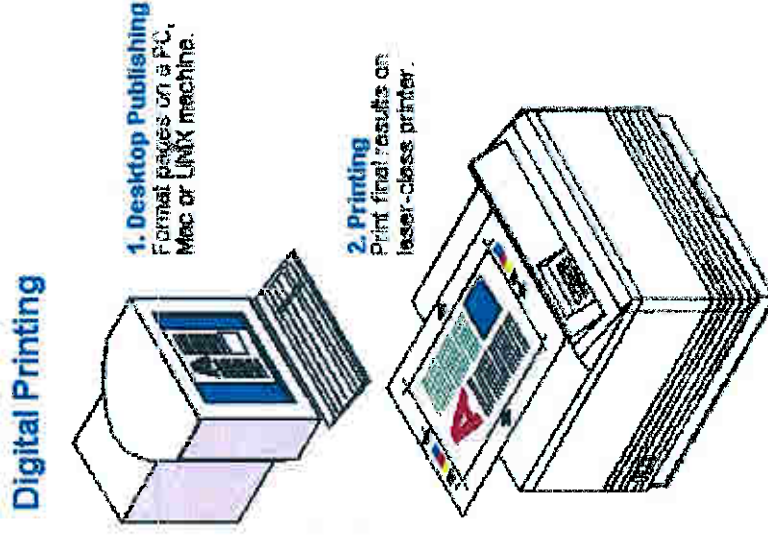
Mechanical Steps Are Eliminated

Digital printing eliminates numerous mechanical steps in the conventional printing process, including making films, color proofs, manually stripping the pieces together and making plates. Instead of cutting and folding printed "signatures" to put the pages in order, software sorts them in memory and prints them in the correct sequence.

Ready for Binding

After printing, the output goes directly to next-stage equipment that can staple, 3-hole punch or bind the paper and even turn it into postmarked packages for the mailroom. Millions of invoices, documents and booklets are printed on large digital printer assembly lines every day.

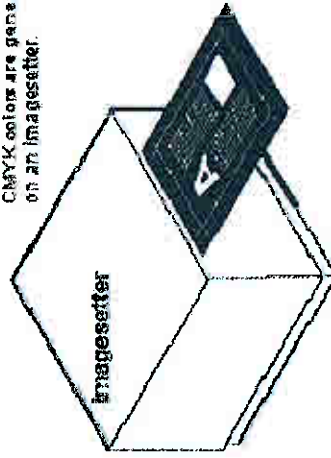

Offset Printing



1. Transfer Files
Obtain electronic files from customer. Check fonts and format for proper conversion from source machine to printer's imagesetter. This is typically done on a Macintosh.

2. Film Making
Films for each of the four CMYK colors are generated on an imagesetter.



3. Color Proofs
Create match prints or color keys to check for proper color registration and as guides for the printer.



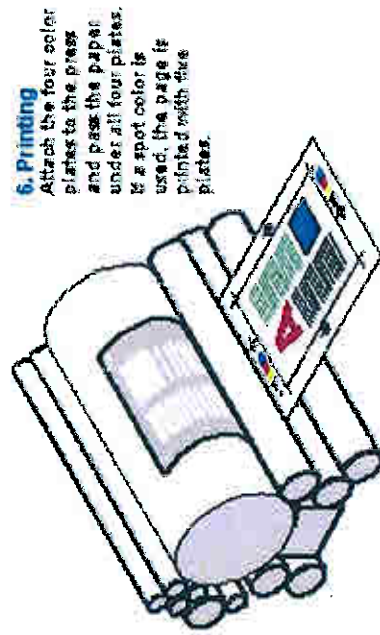
4. Stripping
Lay out pages in the proper order for the binding process. This is a manual process, but large imagesetters (step 2) are performing this task.

5. Plate Making
Create the physical plates that will hold the ink on the printing press. Plates for each of the four CMYK colors have to be created for all the pages.



6. Printing
Attach the four color plates to the press and pass the paper under all four plates. If a spot color is used, the page is printed with these plates.

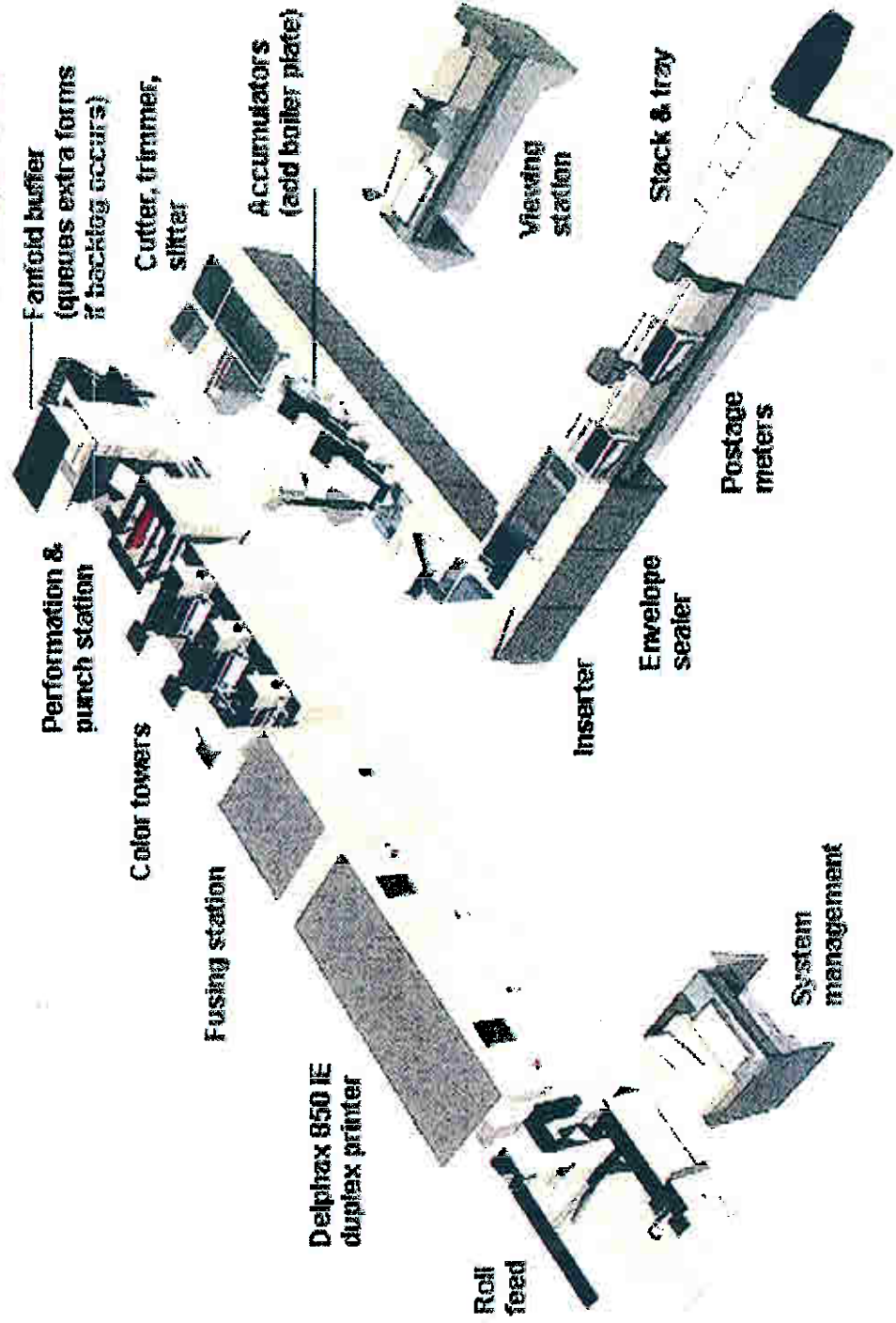

The Output Factory

This digital printing complex produces more than 10,000 finished invoices per hour. They are inserted with other boiler plate into envelopes, sealed, stacked and trayed for mailing. The Delphax printer prints 850 ppm, while the Delphax color towers apply spot color. The additional equipment is from Pitney Bowes, and software from both companies manages the system. 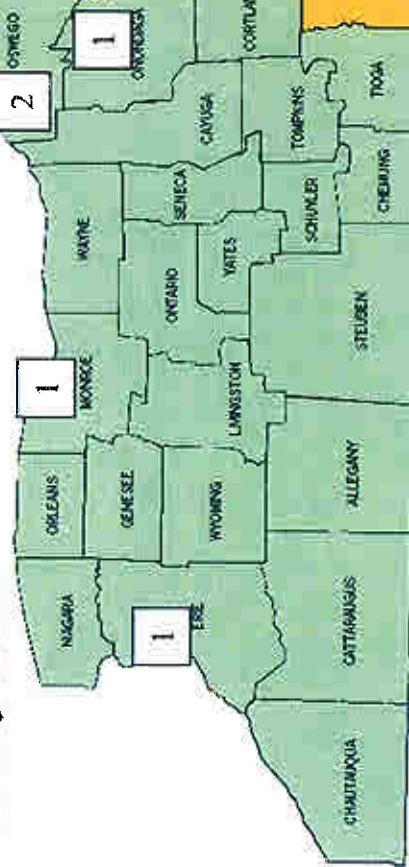

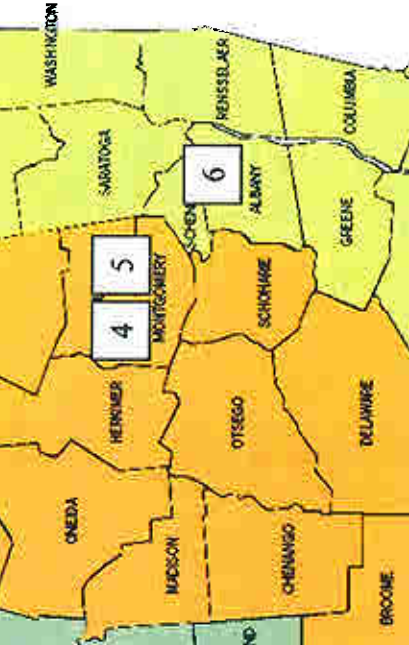

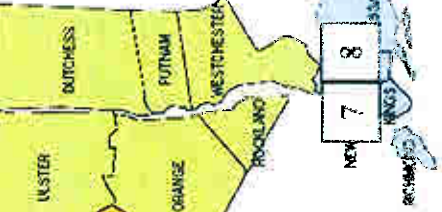

Industry Profile & Economics

Digital Printing and Ancillary Services

The major challenge to the industry is the slowing of total printing shipments (adjusted for inflation) over the next decade. Although nominal printing shipments (not adjusted for inflation) will most likely continue to increase, real or inflation-adjusted industry shipments have most likely peaked for the foreseeable future and are projected to stabilize or decline by as much as 0.5 to 1 percent per year to 2020 before possibly beginning to grow again around 2025.

The major cause of this challenge is the projected decline of conventional ink-on-paper print which may decrease 2 to 3 percent or so per year over the next twelve years. There are multiple reasons for the slowing of conventional print, but primarily it is the result of competition with other (non-print) media and the shifting of conventional print to digital print (in contrast there is also some increase in offset print volumes from the combination of offset and digital printing in some print jobs). Even with this decline, however, conventional print will remain large in an absolute sense. Currently, conventional ink-on-paper print comprises around two-thirds of total printing volume in the U.S. or approximately \$111.6 billion in annual shipments. By 2020 this volume may decline to around \$77 billion to \$87 billion (in real terms—it should grow on a nominal basis), thus remaining a very large business segment.

On a more positive note, there is significant opportunity on the horizon since industry shipments of digital-based print and printers' ancillary services are expected to grow at fairly healthy rates during the same period. In fact, much of the growth of digital print is a result of the digital displacement of offset printing. Digital print currently accounts for around 22 percent of printers' shipments or about \$36.7 billion. Depending on the scenarios explored in this report, this volume could grow between 2.5 percent and 3.5 percent per year. This growth is coming from two sources—conventional print moving to digital process and new business as a result of digital print's capabilities in shorter runs, versioning, and personalization. By 2020, the growth in digital print could add \$13 billion to almost \$20 billion to annual industry shipments.

The other opportunity area, printers' ancillary services, currently accounts for approximately \$18 billion or 11 percent of total industry annual shipments. By 2020 ancillary services may grow by \$2 billion to \$5 billion in additional shipments per year.

In fact, there is potential for total inflation-adjusted printing shipments to begin growing again sometime around 2020 as the increases in digital print and ancillary services outweigh the decline in conventional printing shipments.
