Dear Ms. Irvine:

New York State Industries for the Disabled, Inc. (NYSID) is applying to have Mail Fulfillment Services approved by the NYS Procurement Council as a Preferred Source Offering. Procuring agencies now require a complete turnkey solution for mail fulfillment services. All aspects of the job from letter to label to envelope to mailing must be performed by the contractor. In order to be able to provide mailing services to government agency customers NYSID is requesting that Mail Fulfillment Services be added as an umbrella service, inclusive of all the current offerings. Government agencies no longer only seek to have NYSID strictly process their mail, which includes collating, folding, inserting labeling, packaging, presorting of all classes, distribution, etc., but now also require production of the documents to be mailed. Meeting the requirement of producing the documents to be mailed is vital to the form function and utility of most procuring agencies' Mail Fulfillment Service needs. Should Mail Fulfillment Services be approved for addition to the List of Preferred Source Service Offerings we recommend removal from the List the current approved sub-categories of Cheshire Labeling, Collating, Packaging, Distribution, Folding and Inserting, Inkjet Labeling, Presort, All Classes, as all of those components would now be included within Mail Fulfillment Services. The production component of mailing contracts is a highly-automated process that will require a minimal amount of manual labor; the bulk of the direct labor is contained in the remaining sub-categories already approved for NYSID under the heading of Mail Fulfillment Services. All documents produced for NYSID contracts will be directly related to a mailing task. Once again, in order to continue providing mailing services to meet the form, function, utility requirements of government agency customers and provide employment opportunities to individuals with disabilities within this service offering, NYSID requests that document production be included as a component of Mail Fulfillment Services.

We have provided mailing services to a multitude of government agency customers for the past 25 years, but this application serves as an update of the definition of the service, reflecting the technological changes in mailing services.

Employment of People with Disabilities

New York State has the fourth highest number of residents with disabilities in the US, after California, Texas and Florida. Unfortunately, New York State is below the average rate of employment for people with disabilities; 33.6% of New Yorkers with disabilities are employed. By contrast, 74% of New Yorkers without disabilities are employed. Nationally, 34.4% of adults with disabilities are employed, compared to 75.4% of people without disabilities. Over the past 12 years, the Procurement Council has approved four new Preferred Source services for NYSID: Digital Imaging, Industrial Laundry, Secure Document Destruction and Electronics Recycling. In 2015, those four services alone added 315 FTE (Full-Time Equivalent) jobs. In that same time, those services employed workers to perform 616,000 hours of labor. (See attached chart titled “Statewide Approved Services Since 2004”.) In 2015, NYSID contracts for Mail Fulfillment provided 104,141 labor hours for New Yorkers with disabilities.

NYSID Members

There are five NYSID members independently offering Mail Fulfillment Services: Center for Disability Services in Albany, Fedcap Rehabilitation Services, Inc. in New York City, Southeast Works in Depew (Erie County), Warren, Washington & Albany Counties Chapter of NYSARC in Albany, and Westchester County ARC in White Plains.

Center for Disability Services (CFDS)

CFDS serves about 15,000 people with disabilities. They employ approximately 165 individuals with disabilities in their mailing division. Their hourly pay rates for Mail Fulfillment employees varies between \$9/hour - \$21/hour. They have invested between \$2 million and \$3 million in equipment related to Mail Fulfillment Services plus \$250,000-\$350,000 in training costs.

CFDS has been providing mailing services for over 30 years. Their customers include:

Fedcap Rehabilitation Services

Fedcap serves 548 people with disabilities. Fedcap's on-site and off-site contracts employ 46 people, including managers, supervisors and leads. 33 of the employees have disabilities. Their average pay rate for Mail Fulfillment Services is \$11.00/hour.

Fedcap leases their equipment for mail fulfillment; between October 1st 2014 and September 30th 2015, mail fulfillment spend on equipment was \$162,000. They anticipate spending 3%-5% more over the next year. Fedcap has been providing mailing services since 2008. Their customers include:

Southeast Works

Southeast Works serves over 500 people with disabilities, and they have been providing mailing services for over 20 years. They employ about 20 individuals with disabilities for Mail Fulfillment Services, and they pay piece-rate derived from Prevailing Wage which is currently \$10.20/hour. Their customers include:

Warren, Washington & Albany Counties Chapter of NYSARC (WWAARC)

WWAARC serves almost 1,000 people with disabilities. They employ 61 people in mailing services, 58 of whom have disabilities. Their typical pay rate for Mail Fulfillment Services is \$9.17/hour. They have been providing mailing services for 39 years. WWAARC has invested over \$90,000 in equipment related to Mail Fulfillment Services. Their customers include:

Westchester County ARC

Westchester ARC serves 5,489 people with disabilities, five of whom are employed in mailing services, all earning minimum wage. Westchester ARC has been providing Mail Fulfillment Services for 22 years, and have invested about \$2,000 in equipment for those contracts. They are performing Mail Fulfillment for the NYS Office of Court Administration.

All five of these NYSID member agencies have invested in equipment in anticipation of Mail Fulfillment contracts. The jobs associated with mailing services create opportunities for people with a diversity of disabilities while training workers in marketable skills.

Capabilities

Jobs in Mail Fulfillment Services provide jobs to workers with varying abilities; it is an ideal industry for rehabilitation agencies that employ people with a diversity of functional abilities. The labor steps included in Mail Fulfillment Services are:

1. Production

- Prepare and process electronic files provided by customers for production.
- Unwrap reams of paper and load copier paper trays.
- Load toner into the copier.
- Clear jammed paper paths of the copier.
- Unload the final copied product.
- Validate counts and output quality.
- Ensure that the paper is not curling.
- Complete work orders.
- Deliver copies to the next process.
- Digital Printing is not an approved preferred source offering, but may be a component of mail fulfillment services only when digital printing accounts for less than 25% of the direct labor cost of the contract.

2. Folding and Inserting

- Insert paper by hand or by machine.
- Hand-fold multi-sheet notices that are too large to be folded by machine.
- Unload the inserted envelopes from the inserting machine into mail trays.

3. Metering

- Feed envelopes into a postage meter machine.

4. Mail Presort Services

- Place the envelopes into a sorting machine, which applies a barcode.
- Sort the envelopes by zip code. Order and co-mingle into mail trays to gain postal discounts.

- Monitor the mail trays, and remove them as they are filled.
 - Palletize mail trays.
 - Wrap pallets and prepare for the transportation to the post office.
 - Unload the sorter bins.
5. Finishing
- Fold (both by machine and by hand).
 - Saddle stitch or other type of finishing.
 - Insert into envelopes and seal.
 - Seal tabs for certain mailers such as flyers, newspapers, etc.
 - Apply labels or ink jet directly on the piece.
 - Collate and fulfill mail.
6. Collating, Packaging, Distribution
- Assemble by hand, collate, and insert into packages.
 - Retrieve inventoried material for mailing/shipping.
 - Prepare mail for UPS/USPS package distribution.
7. Post-mailing services
- Perform Data Cleansing Services to comply with USPS regulations and delivery standards.
 - Receive returned postal mail.
 - Scan mail pieces.
 - Track mail electronically.
 - Shred mail pieces once scanning is complete.
 - Insert and unload trays and bins.
8. Deliver mail to post office
- Messenger/ Courier Services
 - Pick up materials from the customer or deliver to the customer.
9. Onsite Mailroom Services
- Includes all aforementioned services performed at customers' locations.
10. Offsite Mailroom Services
- Includes all aforementioned services performed at our service providers' locations.

Mail Fulfillment contracts do not and will not include:

- Calendars
- Offset Printing
- Perfect binding
- Custom-printed carbonless forms
- Typesetting
- Engraved stationary or engraved business cards
- Silk screen reproduction
- Map printing

NYSID contracts for Mail Fulfillment Services will continue to comply with disabled labor ratios for Preferred Source providers, as detailed in the OGS Preferred Source Guidelines in section D6a, <http://www.ogs.state.ny.us/procurecounc/pdfdoc/psguide.pdf>, and the State Finance Law, Article 11, Section 162(7)(i), <http://public.leginfo.state.ny.us/lawssrch.cgi?NVLWO:>.

Market

Open Book NY listed 12 contracts for Mail Fulfillment Services among NYS agencies. (See chart titled “Open Book NY Contract Search Results: Mail Fulfillment Services.”) Two of the contracts are NYSID contracts, and one is held by CFDS. Of the remaining nine contracts, two are held by out-of-state vendors.

Pricing

NYSID Mail Fulfillment contracts have historically been approved individually by OGS. Since we anticipate that future contracts will exceed the \$50,000 threshold, and as such, OGS will continue to approve prices for each Mail Fulfillment contract. NYSID’s pricing for Mail Fulfillment Services is competitive with other vendors in this industry (see attached OGS price approval letters from 2015). NYSID’s pricing for the printing component of mailing contracts are established according to the variables of the customer’s request. Factors that affect pricing include:

- Type of document
- Size of document
- One sided versus two sided copies
- Size of document
- Quality of paper stock
- Black & white versus colored printed copies

Summary

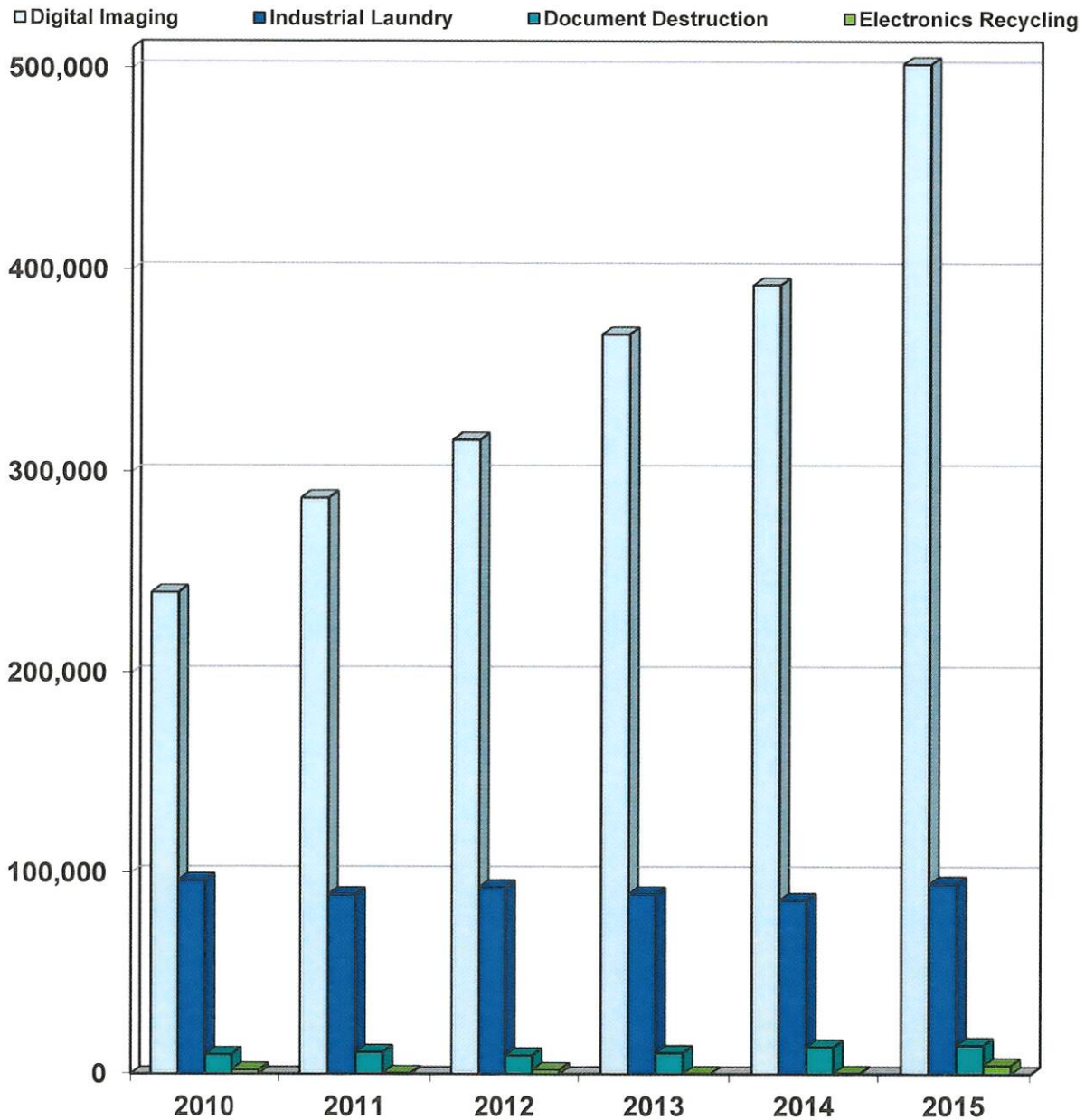

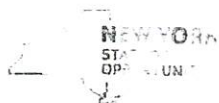
