The Office of General Services (OGS) has given careful consideration to the inquiries received regarding the Laundry and Linen Services (Statewide) Solicitation # 23147 during the Inquiry Period that ended on February 1, 2019.

Answers to the inquiries can be obtained at the Procurement Services Bid Calendar https://nyspro.ogs.ny.gov/content/finding-bid-opportunities. All inquiries are verbatim as received by OGS with the exception of bidder names, which have been redacted.

In addition to publishing responses to the inquiries, OGS has made revisions to the Solicitation documents, which are being released along with the responses to the inquiries. A summary of the revisions is set forth below. The summary of revisions is provided as a convenience. The changes within the Solicitation (Revised February 15, 2019) are redlined. Bids submitted will be evaluated based on the revised Solicitation documents.

REVISIONS TO SOLICITATION (Revised February 15, 2019)

- 1. The Solicitation document has been revised to reflect the most current version where referenced.
- 2. The Solicitation document has been revised to reflect the most current version of Attachment 1 *Pricing*, Attachment 6 *Bidder Submission Checklist*, Attachment 8 *Report of Contract Usage*, and Attachment 9 *Minimum Qualifications*.
- 3. Section 1.2 (A), *Scope*, has been revised to add Products (Entrance Mats, Fender Covers, Work Pants, Work Shirts, and Outerwear) and to include shop towels and huck or surgical towels as examples of Towels under "Contractor-owned Goods."
- 4. Section 1.2 (C), Scope, was added.
- Section 2 (1), Bidder Qualifications, has been revised regarding the "continuous operation" requirement.
- 6. Section 4.3, *Procurement Instructions for Authorized Users*, has been revised.
- 7. Section 5.3, *Price*, has been revised regarding "reasonableness of price".
- 8. Section 5.4, *Price Updates*, has been revised to add a provision to allow Contractors to add a Region.

- 9. Section 5.19, Liquidated Damages, has been revised regarding the notice to a Contractor for a claim of liquidated damages and to clarify in #13 and #14, that calendar days are to be used to determine liquidated damages.
- 10. Section 5.20, Ordering, has been revised to require Authorized Users to inquire of all awarded Contractors within a Region whether such Contractors are able to provide the needed services.
- 11. Section 5.40, Formal Disputes During an Engagement, has been added.

- 1. A Regional Map was added.
- 2. The drop-down box for the "Product Type" field in Regions 1 9 has been updated with the additional Products that were added in Section 1.2 (A), *Scope*, under "Contractor-owned Goods" of the Solicitation (Revised February 15, 2019).
- 3. For Regions 1 9, additional rows have been added for Contractor-owned Goods. If more rows are needed than what has been provided, Bidders are to complete and submit an additional Attachment 1 Pricing. The "Instructions" tab also includes this instruction.
