RE: NYSPSP Application to offer Digital Accessibility and Usability Testing and Remediation Reporting

Services

Description of Application

New York State Preferred Source Program for people who are blind (NYSPSP) is requesting to offer Digital Accessibility and Usability Testing and Remediation Reporting Services (DAUTRSS) as a preferred source offering.

NYSPSP's affiliate agency My Blind Spot in New York City will provide these services.

Marketplace

The sources below were used to assess the marketplace:

- 1. NYSPSP annual estimate provided in the application;
- 2. Survey of comparable products from other preferred source catalogues;
- 3. Survey of results from the Google "site" tool;
- 4. Survey of agencies that may procure similar consulting services;
- 5. OGS Centralized Contracts;
- 6. Search for NYS small business firms through NYS Contract System, SDVOB directory, Hoovers.com, Google, Glassdoor and GSA Advantage;
- 7. Survey of companies identified by search;
- 8. Historical Contract Reporter and BidNet Direct Ads¹; and
- 9. Office of the State Comptroller Open Book NY.

In addition to the above data sources, the marketplace includes purchases done through discretionary spend and purchase cards (P-Card) which are not collected by OGS. The records for P-Card information do not provide spend details on what specific items are purchased. Agencies would have to give P-Card and discretionary spend information voluntarily.

The Preferred Source designation would also provide exclusivity to purchases made by local governments and municipalities, removing the service from the open market for perpetuity. No database records the purchase or spend data of these entities.

ESD performed analysis based on available data provided by publicly available data sources and survey responses. All survey data collected from agencies and businesses is voluntary and self-

reported. Therefore, a complete marketplace analysis is not possible and the analysis below does not encompass the entire spend on DAUTRSS like services.

Each section below includes an analysis and survey results using the available data.

NYSPSP Estimate of Annual Sales

NYSPSP has offered the estimate of their annual first year sales of this service to be \$760,000. With SUNY, CUNY, NYS ITS, Suffolk County Community College and Monroe Community College listed as potential clients.

NYSPSP intends to use automated software, along with sighted and visual impaired individuals, to complete their audits.

Survey of Comparable Products from Other Preferred Source Catalogues

The two other preferred source websites, NYSID and Corcraft, were researched. No other services offered by other preferred sources are substantially similar to this offering.

Survey Results from the Google "site" Tool

The popular Google web search engine offers the ability to limit the scope of searches by using the "site:<modifier>" tool. By using this tool, we can limit index results to a specific domain and get an approximate number of webpages indexed by the engine. This data can then be used to evaluate the partial size of the potential market for DAUTRSS services with the agencies, authorities and municipalities that control these sites. This listing is a small sample of the actual marketplace as there are many domains (examples: *.edu, *.org and *.com) used that cannot be sufficiently narrowed to provide NY based data without discrete searches. There are at least 2,000 websites that are under state and local government control that this decision would affect. A single website can contact thousands of individual pages of data, each would need to be checked for compliance. Sample set of results are listed below.

Survey Results with Select State Agencies

The list of state agencies to interview is based on the information gathered from the application review, one NYS Contract Reporter ad and one BidNet Direct ad. It should be noted that this is a service with a market at all public facing state agencies, authorities and public benefit corporations, although only a limited number of them might procure those services in amounts exceeding the discretionary spending thresholds.

NAICS codes are broad categories that can be difficult to determine where products may be categorized. Since there is no specific NAICS code for this specific service, "World Wide Web Consortium (W3C) Web Accessibility Initiative (WAI) Web Content Accessibility Guidelines (WCAG) 2.1 AA testing" (aka DAUTRSS), a search was conducted for related fields and two NAICS codes, three NIGP codes and one SIC code were identified. Based on these codes alone, it is hard to determine which entities offer these services. Therefore, a smaller subset of 316 was chosen as a sample set to assist in determining the potential marketplace. The term "DAUTRSS" is not a standard information technology term that is used outside of the confines of this application and is not suitable for use as a phrase to generate any applicable company data. Additionally, the term "Worldwide Consortium for Accessibility Governance" generated no results.

Survey Results with Companies

Of the 316 company subset, 17 businesses were surveyed that offer substantially similar services, three of which are not for profit companies.

Contract Reporter Ads

A search was conducted for any ads that were posted from January 1, 2010 to June 22, 2018 for the following phrases: "web content accessibility", "online accessibility", "508 assurance", "508 compliance", "website accessibility" and "accessibility" which generated one applicable opportunity (with one revision) with the City University of New York (CUNY) that closed on 6/24/2018 (UCO-698-1). A similar search was conducted in the BidNet Direct system, which generated one applicable opportunity with Monroe Community College that closed on 1/12/2018 (RFP 18-02).



Analysis & Recommendation

Based on the information from the state agencies and small businesses that were surveyed, we recommend that the preferred source application be denied.

The surveyed agencies indicated there is a very large, active and growing state government marketplace for this field of service. Additionally, there are a significant number of firms (a minimum of 13 were identified in our survey employing over 549 employees, some of them visually impaired), that offer this service in the marketplace.

This application would have a strong negative impact on those businesses if approved, with several businesses noting that state expenditures are 30-50% of their sales in the category, with a potential revenue loss in excess of \$2.5 million dollars from the surveyed firms alone. The nature of this analysis, with the difficulty in quantifying the full number of firms and size of the marketplace, would dictate that this is only a fraction of the true potential for revenue loss to New York State businesses.

The Monroe Community College opportunity (RFP 18-02 from the BidNet direct listing) for example had twenty four document requests noted, with eight of them from NYS firms.

Approval of this application would severely curtail a large portion of the predominately government based market for these firms, many of which are M/WBEs. The applicant (NYSPSP) and their agency (My Blind Spot) already successfully offer this service in a competitive marketplace and could continue to do so if this application is denied. The nature of their organizations already has given them a strong competitive advantage in this field. Our recommendation is to deny the application so that all parties currently in the market place including My Blind Spot can continue to compete for this service.
