Bidder may use additional lines to submit banded pricing for multiple units with quantity discounts. Additionally, the discount may be further increased for each individual transaction with the Authorized User at the time of transaction.

No, Bidders may not include items that have not been approved by SBOE at this time. Please refer to <i>Section 3.3.2, Related Products</i> of the Solicitation. A Bidder may include any ancillary or related Products, as approved by SBOE, meant to enhance the approved E-Poll Book System as submitted for approval by the SBOE. On the Related Products tab of <i>Attachment 1, Pricing</i> , the Bidder shall list any optional upgrade items, ancillary Products, and consumable Products being offered to Authorized Users.

Pursuant to <i>Appendix B, Section 60</i> , where Product is acquired on a licensed basis, the terms contained within Section 60 shall apply.

5	<i>Solicitation</i>	7.2.9	We understand that we are supposed to submit a bidder questionnaire but, it states that this must be done no more than 6 months before the bid date. We were only approved by the SBOE a couple of weeks ago. Are we able to submit within the time remaining to meet the 8/1 decision deadline? We are still waiting on our Vendor ID number.	Yes, the Bidder is able to complete the vendor questionnaire prior to the bid due date, July 16, 2019. Once a vendor has been assigned a Vendor ID number, OGS recommends that the Bidder complete the questionnaire online via the NYS VendRep System.
6	<i>Solicitation</i>	4.4 Content of Bid Submission	4.4 states that we need to include all of the documents and forms, We have already completed and submitted these forms prior to this process. Do we need to submit all of these documents again with our bid or just the proof of acceptance from the SBOE?	Bidders must submit all documents, in the quantities and format(s) specified in <i>Section 4.4 - Content of Bid Submission</i> of the Solicitation. If a Bidder has submitted any or all of these documents under a different solicitation, they will need to be submitted again for OGS review for this Solicitation.
