Following OGS review and approval, the information will be placed in a database used to confirm your eligibility.

Only those parties publicly identifiable as a member of an entity's senior management team (those holding financial responsibility for the entity) will be provided with an organization's assigned OGS Customer ID number. Any inquiries from entity staff will be referred to the parties designated below. The requestor and any additional registrants should be members of the entity's financial or procurement management staff. This protocol was set up to help curb potential fraudulent use of the State Centralized Contracts, while also providing authorized users with additional internal oversight.

Certification of Qualification for Charitable Organizations

Chapter 741 of the Laws of 1985, last amended by Chapter 55 of the Laws of 2012,¹ allows certain charitable organizations to make purchases from centralized contracts awarded by the New York State Office of General Services. For your information, the law reads as follows:

Section 1. In order to ascertain the compatibility with State purchasing needs and the feasibility of extending the benefits of purchasing under the terms of the State's centralized commodity procurement contracts to eligible and qualified charitable organizations and federations of charities, and to county, town or other agricultural societies, the American Institute of the City of New York, and a fair or exposition for youths held by a county extension service association, the provisions of this act are adopted as a program for all counties of the State, whose charities, agricultural societies, youth fairs or expositions held by a county extension service association and said institute as defined therein are authorized to purchase pursuant to the terms of such contracts let by the Office of General Services.

Section 2. (a) Any charitable organization or federation of charitable organizations, as defined in subdivision (b) of this section, maintaining its office in a county of the State and performing all or the predominant part of its charitable, benevolent or philanthropic services or conducting all or the predominant part of its solicitation of charitable contributions in such county and any county, town or other agricultural society, the American Institute of the City of New York, performing their activities in any such county on or after January 1, 1993 is authorized to make purchases pursuant to the terms of contracts let by the Office of General Services, subject to such rules as may be promulgated pursuant to the provisions of Section 163 of the State Finance Law, which may establish limitations with respect to commodities and services and impose such other appropriate conditions upon purchasing as deemed necessary by the Commissioner of General Services in order to protect the State's own purchasing interests; provided that each such purchase shall exceed five hundred dollars and that such charitable organization or federation of charitable organizations shall accept sole responsibility for any payment due the vendor.

(b) For the purposes of this act (i) "charitable organization" shall mean, include and be limited to: (1) a domestic [(i.e., New York)] corporation incorporated pursuant to the [New York] Not-for-Profit Corporation Law, which (A) constitutes a charitable organization registered with the Attorney General, (B) is not an exempted organization as defined in Section 172-a of the Executive Law, (C) renders health, welfare or recreation services, and (D) receives at least fifty thousand dollars in charitable donations and contributions from individuals or private organizations and/or in government grants excluding any fees for services, provided however that such limitation as to the contributions received may be waived by the Commissioner of General Services in his or her discretion; and (2) without regard to the criteria set forth in subparagraph one of this paragraph (i), a special act corporation created pursuant to Chapter 468 of the Laws of 1899, as amended [the Salvation Army], and a special act corporation formed pursuant to Chapter 256 of the Laws of 1917, as amended [Catholic Charities Aid Associations] and a corporation authorized pursuant an Act of Congress approved January 5, 1905 (33 Stat. 599), as amended [the Salvation Army] and a corporation established by merger of charitable organizations pursuant to an order of the Supreme Court, New York County dated July 21, 1986 and filed in the New York Department of State on July 29, 1986 [the United Jewish Appeal-Federation of Jewish Philanthropies of New York, Inc.]; and (ii) "federation of charitable organizations" shall mean, include and be limited to a domestic [(i.e., New York)] corporation incorporated pursuant to the [New York] Not-for-Profit Corporation Law, formed by and consisting of not less than three charitable organizations as defined in this subdivision and performing joint and combined solicitation of charitable contributions by and distribution of the proceeds thereof to such member or constituent organizations, provided that in no event shall the number of any exempted charitable organizations as defined in this subdivision exceed one-third of the total number of the member or constituent organizations of the federation of charitable organizations.

(c) The Office of General Services shall perform all necessary actions to insure adequate notification and education of any organization or organizations eligible to participate in the program authorized by this act as soon as shall be feasible and practicable.
